6 ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment & emergency procedures: Do not try to clean up the leak without proper protective equipment. See section 8 for recommendations on the use of personal protective equipment.

Environmental precautions: Avoid liquid release into sewers/public water. Absorb the small overflows with inert solids. Notify environmental authorities in case of large leaks.

Methods and material for containment and cleaning up: Landfill solids at permitted area. Use registered transporters. Burn concentrated liquids, diluting with clean, low viscosity level. Avoid flame-outs. Assure emissions comply with applicable regulations. Dilute aqueous waste may biodegrade. Contaminated product soil, water, container residues, and spill cleanup materials should not be designated as hazardous wastes. Prevent flow to sewer/public waters. Spread granular cover. Soak up small spills with inert solids. Dispose of in compliance with Federal, State, and Local regulations. Contain/collect rapidly to minimize dispersion.
