People with known allergy/hypersensitivity to peppermint oil should avoid peppermint products.
<b>Other:</b>	Essential oils must be diluted prior to use. It is the sole responsibility of the user to determine the method and amount of dilution required for safe use, which may vary depending on the nature of the intended use. Keep away from children and pregnant women. Use good personal hygiene practices. Provide eyewash stations, quick-drench showers and washing facilities accessible to areas of use and handling.
